DOMINION VOTING MACHINE PROJECT

A republican group including members of TRWF met with the Registrar of Voters for Tulare County, Michelle Baldwin. This very productive meeting reviewed the mechanics of the voting process including auditing of the machines, maintenance and validation of the voting machines and the results of audits of the entire process. From the information gathered the group was more confident of the integrity of voting in Tulare County. Next steps will be determined for improving republican involvement in the voting process.



PLANNED PARENTHOOD IN TULARE

We have confirmed that Planned Parenthood has announced their intention to open a clinic in Tulare. At this time the plans are to build a new clinic near the intersection of Leland and Paseo del Lago. Investigations are underway as to the site specifications and details of this new clinic. Tulare representative are in discussion with other communities who have defeated the development of such a center.
